Concerns: procedure conducted as an open tender procedure for Delivery of a device for analysing the parameters of advanced glycation end products, case number: NZZ/94/P/12.

CONTENTS MODIFICATION OF SPECIFICATIONS OF ESSENTIAL CONDITIONS OF ORDER

Acting under the provisions of art. 38. par. 4 of the Public Procurement Act of 29 January 2004 (consolidated text, Journal of Laws 2010, No. 113, item 759). The orderer modifies the content of specifications of essential conditions of order and implements following changes:

1. In chapter VIII of Terms of References (TOR) "Material provisions of the proposed contract and the payment period" the orderer deletes completely point 2 and instead of introduces the following provision:

"The contractor shall accept the term of payment up to 30 days. The offered amount for performance of the subject of the agreement shall be payable by the Orderer by way of a money transfer into the Contractor's bank account on the basis of issued VAT invoice."

2. In attachment nr 2 to TOR "The Offer Form" the orderer, in IV "Terms of payment - money transfer to the Contractor's account within the deadline of" deletes the following provision:

"IV. Receivables under the contract are payable in the following parts (Chapter 8, item 2 of TOR):

- *1st part amounting to 50% of the offer price, that is, Euro gross within 30 days from the date of issuing the VAT invoice,*
- *2nd part amounting to 50% of the offer price, that is, Euro..... gross within 60 days from the date of issuing the VAT invoice."*

And implements the following provision:

"IV.- the payment in the form of money transfer in term : days (Chapter 8, item 2 of TOR)

3. In attachment 3 to TOR "Draft Contract" in § 5 "Mode of payment" deletes completely the provision in unit 1 and implements instead the following provision:

"The payment for the provided subject of the Contract shall be paid by the Ordering Party in the form of money transfer into account of Contractor indicated in The Offer Form within days from the date of issuing a VAT invoice, what shall take place upon a decent delivery, set-up and test run of the Commodity and Staff training, acknowledged in the mode provided for herein."
